- * Certificate I in Transition Education is delivered part-time over 4-5 years. An annual amenity fee will apply.
- ** Cobram Community House does not deliver HLTAID012 Provide First Aid in an education and care setting as part of the Early Childhood Education and Care course. If students do not hold a current qualification, they will be required to complete a course at their own cost and apply for a credit transfer. Students enrolled in Early Childhood Education and Care course are required to have a current Working with Children Check. There is no charge for a volunteer WWCC.
- *** Only Aboriginal and Torres Strait Islander students studying in a government-subsidised place are eligible for a concession on diploma level courses.

Fees and Payments

- A deposit must be paid upon enrolment
- Where fees are not paid in full a payment plan must be agreed upon
- Where fees are over \$1,500, no more than \$1,500 will be collected in advance prior to commencement. The remaining fees will be collected pro-rata, so that no more than \$1,500 will be held in advance at any one time.
